### **Clare Veteran's Centre**

• Awaiting word on our application to the Nova Scotia Department of Communities Culture and Heritage, under the Community Facilities Improvement Program, for funding to assist with renovation of the current upstairs washroom facilities

## Gran-Fondo

- As of June 21<sup>st</sup>, 354 people have registered. Deadline for jerseys is July 31<sup>st</sup> (expecting big uptake prior to deadline)
- Sponsorship campaign was launched on May 18<sup>th</sup> targeting private sector. The goal was \$10,000. To date, \$9,300 has been raised plus an additional \$5,000+ in in-kind contributions.

### **Recycling Plant:**

- Equipment has been removed
- Clare Machine Works will be leasing the building as of December 1<sup>st</sup>.
- Move in date has been pushed to December 1<sup>st</sup> to avoid double occupancy. Less complicated and resolves potential issues relating to joint liability.

### **Community Clean-up Program:**
