# **PROJECT FILES:**

### Church Point Sewer Treatment Plant (\$198,628)

- Work to convert the sewer treatment plant in Church Point from a chlorine-based system to a UV system is complete and we are now compliant with the revised provincial standard.
- Focus is now shifted on the 3 control panels in Meteghan. Timeline for installation is Fall 2017.

### **Clare Veterans Centre**

- The lettering for the exterior has been ordered. Digby Print is the supplier and will also be responsible for the installation.
- We are also exploring options for a bigger LED digital display (same width, greater length). Subject to cost and budgetary constraints.

### Sewer Extension – John Thibodeau Road (\$557,000)

- Both the drawings for the site and the specifications are now complete.
- The tender has been posted in local print media, social media, and on the Province's procurement website. The tender document itself will be available for download on the Province's website.

### Cultural Hub Project (\$200,000)

- Building renovations have commenced.
- Courtroom has been renovated and new tenants have been invited to move into the new space.
- Minor items remain pertaining to the interior of the building. These are being addressed by either municipal staff (when appropriate) or skilled trades.
- The roof is complete.
- The base for the new entrance has been poured with framing to commence shortly.
- Looking at possibility of expanding parking lot to accommodate increased traffic
- Signage and landscaping will commence once exterior renovations are complete.

### <u>Gran Fondo:</u>

- To date, 377 participants have registered. This represents a slight increase when compared to last year's numbers for this same time of year (6%).
- Of these 377 participants, 81 are from out of province. Last year, a total of 100 were from out of province. This represents a marked increase from last year

### Cape St. Mary Lighthouse (\$167,025):

- A total of 4 tenders will be issued later this week in order to carry out this project:
  - Exterior Renovations
  - Site Improvements
  - o Signage
  - o Interpretive Panels
- These will be posted in local print media, social media, and on the Province's procurement website.
- All 4 tenders will have a closing date of July 14, 2017.

### Ecopark:

- As previously reported, the RFP is now closed. No proposals were received in response to this official request.
- A more focused effort will now be launched directly targeting those businesses who have previously expressed (and continue to express) interest in the facility.

# FINANCIAL:

- As of May 31, 2017, the Municipality has recorded \$7,387,842 (82.03%) in revenues versus \$1,340,650 (14.89%) in expenses, for a net income of \$6,047,192 (67.14%).
- As of June 20, 2017, the Municipality has a balance of \$1,301,328 in its general account and a total reserve balance of \$2,949,982
  - o Operating reserve \$436,714
  - o Capital reserve \$1,763,064
  - o Landfill closure reserve \$316,046
  - o Gas tax reserve \$434,158
